Election Notice and Candidates....

The Ohio Soil and Water Conservation Commission will cause an election of Supervisors of the Athens Soil and Water Conservation District (SWCD) to be held in accordance with Chapter 940 of the Ohio Revised Code. Individuals who own or occupy land within the Athens SWCD and are 18 years of age or older may vote for supervisor.

There are 3 ways an eligible voters can cast a ballot:

- 1. At the Athens SWCD office from September 18, 2023 until October 17, 2023 during normal business hours of 8:00 am 5:00 pm Monday Thursday, and 8:00 am 4:30 pm on Fridays.
- 2. At the SWCD Annual Meeting, which will take place at Federal Valley Resource Center, 8225 S.R. 329, Stewart, Ohio 45778 on Thursday, October 19, 2023 from 4:30 pm 5:30 pm; or
- 3. By voting absentee from September 18, 2023 until October 17, 2023 by requesting the Voter Verification and Election Ballot from the Athens SWCD office at 69 S Plains Road, The Plains, Ohio 45780, or by calling 740-797-9686 ext. 6280, or by emailing cathybobo@athensswcd.org. Absentee ballots must be received by 5:00 p.m. on Tuesday, October 17, 2023.

Two Supervisors will be elected to a three-year term commencing January 1, 2024, and ending on December 31, 2026. Nominees are: Zachary Crabtree, Brenda Dahse, and Gary Willison. (see bios below)



<u>Zachary Crabtree</u> - Zach attended The Ohio State University where he studied Agronomy and Plant Science. While in school he participated in the NRCS student trainee program for 4 years and worked in multiple locations across the state helping with EQIP. This included working in the Athens office for a summer. He owns an excavating and construction company, ZC Excavating LLC, where he operates and performs projects locally to southern Ohio for residential and commercial. Zach also farms with his dad and wife in Albany, Ohio. They raise corn, soybeans, wheat, hay and freezer beef.

<u>Brenda Dahse</u> - Brenda is a life long resident of Athens County. She and her husband Kevin reside on a 52 acre horse farm in Bern Township. They have installed fencing, watering systems and structures to accommodate their current livestock operation. Brenda currently holds the positions of Chairman and Fiscal Agent on the Athens SWCD Board of Supervisors where she has served for the past 12 years. She is currently an Area 5 Director for the Ohio Federation of Soil and Water Conservation Districts and a member of the District 18 Buckeye Hills Natural Resources Assistance Council. Brenda has been employed as the store manager at Buckley Brothers, Inc. in The Plains for



the past 20 years. Prior to that, she worked as the office manager for Landmark, Inc. for 5 years. Brenda is very generous with her time in helping her nieces, nephews and area youth with their 4-H projects. "It is very satisfying to see kids succeed with their projects" Brenda says. She enjoys horseback riding, gardening, and the outdoors.



<u>*Gary Willison*</u> - Gary graduated from The Ohio State University, where he received his bachelor's and master's degrees in Forest Management. He retired from the US Forest Service after 34 years, where he managed the forest resources in four national forests. On the Wayne National Forest he managed a Watershed Team that completed 54 abandoned mine land projects which greatly improved water quality in the Monday Creek Watershed. Gary also worked closely with Ohio Department of Transportation to minimize effects to wildlife

and soil and water resources while managing the US Route 33 Bypass around Nelsonville. Currently he is a forestry instructor at Hocking College and a consulting forester in Southeastern Ohio. Gary holds the position of Treasurer on the Athens SWCD Board of Supervisors where he has served for the past 3 years. Gary lives on a farm in eastern Athens County with his wife and son where he raises Christmas trees and produces maple syrup.

Soil Test and Fall Liming Applications

When was the last time you sampled the soils in your lawn, garden, crop fields or pastures? This easy and inexpensive process is often overlooked but is an incredible tool when it comes to getting the most out of our soils. Testing can be done in the spring or the fall and while it doesn't need to be done annually, you should consider testing once every three to five years. Results from your soils test can be used to add amendments in the proper and safe quantities.

Why is this important? When the soil pH becomes too acidic, certain nutrients needed for proper growth (such as nitrogen, phosphorus, potassium, and calcium) become unavailable to the lawn, so the grass is unable to grow properly. Ideally, we will want our soil pH to be in the 6.0-6.8 range but there are exceptions to this. There are situations when we want more acidic soils – when growing blueberries or rhododendrons for example. Peas, lavender and hydrangeas all do better in more alkaline soils. Regardless of what you're growing, understanding your soils and using this simple procedure to determine your needs will improve your results.

While fall and spring are both good times to do lime applications, fall has the added advantage of rain, snow, and freezing / thawing cycles will help breakdown applied lime. Generally speaking it will take a minimum of 6 months for change in pH to start occurring. It is certainly a slow process – so taking the time and effort to maintain proper pH is a worthwhile strategy.





The Athens SWCD has partnered with Ohio Pollinator Habitat Initiative again this year to be a designated Common Milkweed Pod Collection Station. The collection will begin September 1st and end October 30st. Let's make this year's pod collection successful by following these simple tips!


- Collect pods from Common Milkweed plants only.
- Collect the pods when they are dry, grey, or brown.
- If the center seam pops with gentle pressure, they can be harvested.
- Store the pods in paper bags; plastic bags collect unwanted moisture.
- Put the date and county collected on the bag when you turn them in.
- Keep the pods in a cool, dry area until you can deliver them to the Athens SWCD office.
